Greene submitted to the Directors the audit report made by Mr. Turner S. Underwood for the fiscal year ending May 31, 1950. This report was compared to reports of previous years - special attention being given to the fact that the City of Pueblo is reducing its delinquent balance and that in the last five years the current assets of the District had increased from \$408,234. as of May 31, 1945 to \$689,387 as of May 31, 1950.

Mr. Holmes stated he would like to have the opinion of the other Directors as to the advisability of transferring some of the funds of the District which are on deposit in the First "ational Bank to the new Arkansas Valley Bank. Mr. Mathis stated he personally had deposited a substantial amount in the new bank and believed helping the new institution get started was advisable. Mr. Mathis then moved that the Treasurer of the District be instructed to deposit \$25,000 in the Arkansas Valley Bank. Mr. Holmes seconded the motion which was carried.

There being no further business, the meeting adjourned.
