BE IT RESOLVED By the Board of Directors of The Pueblo Conservancy District that the settlement made by the District with the American Surety Company of New York, whereby the said Surety Company is to pay The Pueblo Conservancy District the sum of Eighteen Thousand and no/100 Dollars (\$18,000.00) for claims growing out of its surety bond covering Contract No. 23 of A. S. Hall & Son with The Pueblo Conservancy District, be and the same is hereby approved and ratified, and the action heretofore begun against the said Surety Company on said bond is hereby ordered dismissed as to said Surety Company with prejudice, and the bond of said Surety Company is hereby ordered returned to them endorsed "Returned for Cancellation", and all liability of the said Surety Company on the said bond is hereby declared to be cancelled and satisfied; all of the foregoing, however, without prejudice to the rights and claims of The Pueblo Conservancy District against A. S. Hall & Son.

Mr. Nuckolls seconded the motion, the vote being as follows:

Thereupon the Chairman declared the motion passed.

There being no further business to come before the meeting, it was, upon motion, adjourned.
