Holmes read to the Directors a letter he had received from Joe Holloran of the Holloran Investment Company. Mr. Holloran stated in his letter that he represents a party who desires to purchase from the District the land the District owns which lies between the new Elizabeth Street extension and the Missouri Pacific Railread tracks. Holloran wants a thirty day option on the land at the price of \$30,000 less a ten per cent real estate commission.

In discussing this matter the Directors referred to a map furnished by the City Engineer showing the exact location and dimensions of the Elizabeth Street highway. S. F. Elliot had also shown the location of the new highway on a map which shows the property the District owns in the vicinity.

Dear Mr. Holmes:

A prospect has contacted me in regard to the property owned by the Pueblo Water Conservancy District between South Santa Fe Avenue, South Main Street, the new Elizabeth Street Extension, and the Missouri Pacific Railroad on the South, consisting of approximately two and one-half acres. Realizing that your land has been retained by the Conservency District for water storage purposes, but, understanding that additional dikework can be done to replace it. I am wondering if the District will sell this land and return it to the tax rolls of the City and County of Pueblo?

A rough estimate of the total cost to put this land in saleable condition and level with Elizabeth Street would be about \$92,500. \$52,500 is the estimated cost of piping for the Southern Colorado Power Company easement and fill to the top of the pipe. \$40,000 is roughly estimated for additional fill, about fourteen feet to street level. In my opinion the value of the property in street level condition is approximately \$120,000. My prospect has asked me to obtain a short-term option (30 days will probably be sufficient) for the purchase of your ground, as is, at \$30,000. I have enclosed a standard Receipt and Option form used by our firm. The prospect would be agreeable to include his special use of the ground in the option.

If the \$30,000 is not acceptable, would you please tell me what figure would be necessary to make it worth the District's selling, allowing also for a 10% Professional Realty fee.

Your cooperation on this matter, at your earliest convenience, will be greatly appreciated.
