November 25, 1924

BE IT RESOLVED By the Board of Directors of The Pueblo Conservancy District that assessments heretofore levied in the total amount of \$50.00 or less upon any parcel of land as shown by the Conservancy Appraisal Record be, and the same are, hereby permitted to be paid in full at any time with interest to the next succeeding semi-annual date of payment; provided, however, that nothing herein shall be construed to deprive any owner of land of the right to pay in full the number of installments as shown by the Conservancy Appraisal Record if he so desires.
