March 3, 1949

Greene reported that he and Charley Rose had gone to Denver on Monday, February 28th, 1949, to meet with a sub-committee of the Appropriations Committee of the House of Representatives regarding a pending bill authorizing payment by the State of Conservancy tax on the Colorado State Hospital property.

Mr. Rose reported what had taken place at the meeting. Greene returned to Pueblo on Monday but Rose stayed three days during which time he saw various state officials including the Governor.

Greene reported he had received from the Army Engineers at Albuquerque a set of plans and specifications for building the Emergen cy Levee east of Runyan Field. Bids are to be opened March 22, 1949.

Greene also reported, Mr. R. G. Cooper of the Legal Department of the Army was in town and that he, Cooper, Greene, Elliot and Rose were trying to straighten out discrepancies in the right-of-way map the Army Engineers had prepared in connection with the plans for the Emergency Levee.

Greene reported to the Directors regarding a Treasurer's Deed having been issued to the District on property which stood in the name of Tillie Speken; the property being Lot 25, Block 49, South Pueblo. Treasurer's Deed was issued March 2, 1949, on Certificates held by the District for the years 1941 to 1944, inclusive, which could have been redeemed by Tillie Speken prior to the District making application for Tax Title for the sum of \$350.36.

Greene said that Mrs. Speken's son had asked if the District would deed the property back to his mother for \$400.00.

Greene explained that the property was of questionable value and that if the District endeavored to get good title to it, it would envolve getting an abstract and quieting the title and that he believed the Speken's would offer all the resistance possible. Greene said he believed the interests of the District were better served by accepting not \$400.00 but \$425.00 for a Deed to Mrs. Speken and consider that this sum was received as an adjustment of taxes rather than as a sale price. Mr. Pryor then introduced the following resolution and moved its adoption.

BE IT RESOLVED that the President be authorized to execute a Quit Claim Deed to Tille Speken on Lot 25, Block 49, South Pueblo, in consideration of the payment by Mrs. Speken of \$425.00; the payment being considered an adjustment of taxes, and that no greater sum net can be obtained from this account.

Mr. Mathis seconded the motion to adopt this resolution which was unanimously carried.

There being no further business, the meeting adjourned.
