MINUTES OF A MEETING OF THE BOARD OF DIRECTORS OF

THE PUEBLO CONSERVANCY DISTRICT

March 30, 1943

A meeting of the Board of Directors of The Pueblo Conservancy District was held in the office of the District at 2 P.M. March 30, 1943. Dir3ctors present: John M. Holmes, Frank Pryor and W. T. Mathis. John M. Holmes called the meeting to order and presided over same.

Minutes of the meeting of September 19, 1941 were read and approved.

Report was made by Mr. Holmes on the work done at the south end of the Union Avenue Viaduct where the seepage had caused a break in the rock wall embankment put in by the City and District under a W. P. A. project. Mr. Holmes had taken engineers from the Denver & RiblGrande Railroad Company for consultation and had asked Arthur & Allen to proceed with the work of draining and filling this seepage area. The bill of Arthur & Allen was presented for this work and it was moved by W. T. Mathis that the report of the work and payment for same to Arthur and Allen, Fountain Sand & Gravel Co., Bernstein Bros. and Standard Fire Brick Co. be approved. Mr. Pryor seconded the motion, the vote being unanimous in favor of same.

The audit of May 31, 1942 was discussed and ordered filed.

Mr. Holmes told of the purchase of the Mullet property (Voucher No. 10577) and motion was made by Mr. Mathis that this transaction be approved. Seconded by Mr. Pryor. Vote unanimous on same. Discussion was had on possibility of tearing down this building and asking the city to fill in the excavation under same. Mr. Holmes said he would go into the matter with some wrecking concern.

Mr. Holmes reported the levee on southern bank of the river

between the Lower Railroad Bridge and The Santa Fe Avenue Highway bridge should be taken care of where the slab of concrete has been broken off. He was authorized to have this matter looked into and go ahead with a feasible plan to remedy the situation before high water might interfere.

Mr. Pryor made a motion that the Board approved action of John M. Holmes in sale of tax certificates as follows:
