# LEASE

THIS LEASE, WITNESSETH: That S. F. Elliot and V. R. Blackburn hereby lease to The Pueblo Conservancy District, a Public Corporation, the following described premises:

That certain rear room space, 19 feet by 39 feet in dimension, located in the Northeast portion of the building owned by Lessors located at 113 East Fifth Street, on Lot Sixteen (16), Block Twenty-250,(23) Original Town of Pueblo Plat, in the City of Pueblo, Pueblo County, Colorado;

for the term of five (5) years commencing <u>March</u> 1st, 1955 and ending <u>March</u> 1st, 1960, at a rent of One Hundred Twenty-five and No/100 (\$125.00) Dollars per month, payable each month.

Said Lessors covenant that they are the owners of said premises with full title and right to execute this lease.

Said Lessee agrees to pay said rent unless the premises shall be destroyed or rendered untenantable for its use by fire or other cause; not to use said premises for any unlawful purposes; not to assign this lease without the written consent of the Lessors; and at the expiration of this lease to surrender said premises in as good condition as they now are, reasonable wear and tear, use under this lease, and unavoidable casualties excepted.

It is further especially covenanted and agreed between the Lessors and the Lessee as follows:

1. That within a reasonable time the Lessors will pave parking space in rear of the premises aforesaid, and there supply exclusive parking space

- for Lessors for three (3) cars; and additional space on necessary special occasions.
- 2. That the Lessors will furnish and supply a rear entrance to the room aforesaid; and also a front entrance through a hall for common use opening on 113 East Fifth Street with privilege of signs of Lessee in hall and at front entrance.
- 3. The Lessors agree not to put the unleased portion of the premises to any use that diminishes the value of the leased portion for general office use by the Lessee; and the Lessee agrees to use and occupy the leased portion of said premises for general office purposes.
- ing the leased portion of said premises for its own use; and may install equipment and fixtures therein including vault, lighting, telephone, heating and cooling apparatus and toilet facilities, all at the expense of the Lessee. At the termination of this lease such installations and fixtures may be removed by the Lessee using reasonable care to avoid damage to the premises.
- Lessee as follows: To answer telephone calls and inquiries during the daytime office-hour absence of representative of the Lessee from the office of the Lessee, upon satisfactory installation by Lessee of telephone connections and interchange between the leased room and the office of the Lessors.

- 6. The Lessee agrees to pay the expense of all utilities furnished for the leased room except water charges which shall be paid by the Lessors.
- 7. The Lessors agree to satisfactorily partition the leased room aforesaid from contiguous room of the Lessors.
- The Lessee is hereby granted by the Lessors the right and option to renew and extend this lease at the termination thereof for a like period upon such terms as are agreeable to both parties, and upon 90 day same terms; Said option to be exercised by notice prior notice of intent.

Greene submitted records of Certificates cancelled by Court Decree where property has been acquired by Tax Title based on delinquent taxes (general). Cancellation records submitted are numbered 83, 84, 85, which is attached hereto and made a part hereof. Greene reported that to the best of his knowledge this cancellation was in order. Upon motion of Mr. Mathis, seconded by Mr. Pryor, the cancellation of taxes are shown on pink sheets Nos. 83, 84, 85, were ratified and approved.

The Meeting held on this date is the first meeting held in the new office of the District in the building owned by Elliot and Blackburn at 113 East Fifth Street. The headquarters of the District moved to the new office on March 18, 1955, although the lease on the premises, copy of which is attached hereto, is dated March 1, 1955.

Also attached hereto is a copy of the Court Order signed by Judge Philip Cabibi reappointing the Directors of the District for terms commencing April 12, 1955. A copy of the signed Oath of Office of each of the Directors is also attached hereto.

At this point Holmes requested Greene to leave the room. Holmes reported to his fellow Directors that on April 18, 1955, he had received a written resignation from Greene as Secretary-Treasurer. Greene gave as his reason for resigning the fact that May 31, 1955, would be the tenth anniversary of his association with the District during which time he had not taken a vacation and that he was tired, and May 31st seemed the logical time for the effective date of his resignation as the Auditor would audit the books as of that date, it being the end of the District's fiscal year. In the discussion that followed the fact was developed that in many branches of industry an employee was permitted to accumulate his vacation time over a period of not to exceed two consecutive years and at that time should the employee decide to work instead of taking his vacation he was paid not only for the time worked but in addition was paid his vacation allowance. Holmes also reported on the several meetings he had with Greene with reference to his resignation or his continuation of service with the District. He further stated that while the Directors felt justified in paying Greene as much as \$275.00 per month, Greene had voluntarily offered to reduce his salary to \$80.00 per month for an indefinite period commencing May 1, 1955. In consideration of the above discussion and facts Holmes made the following motion:

"I move that in view of the facts developed and stated that Mr. Greene be paid his regular salary for the month of April and a like amount covering vacation allowance for an accumulated period of two years and that a check be drawn in his favor in the amount of \$650.00 for the month of April in lieu of his regular salary check of \$325.00; and that the Directors accept Mr. Greene's proposal commencing May 1, 1955, that his salary be \$80.00 per month for an indefinite period."

Seconded by Mathis and unanimously carried.

Holmes then presented his statement for services rendered to the District covering the three months of January, February and March. The statement was discussed and explained in detail. The following motion was made by Mathis:

"I move the approval of the statement of Holmes for personal services rendered to the District during the month of January, February and March, and that the amount be approved and ordered paid."

Seconded by Pryor and unanimously carried.

The subject of the retainer fee as being paid to Charles M. Rose, Attorney for the District, was discussed to some extent and the following motion was made by Pryor:

"I move that Holmes be requested to take up with Attorney Rose the amount to be paid to him as a retainer fee as Attorney for the District."

Seconded by Mathis, unanimously carried.

The financial condition of the District as reported By Greene was discussed. Mathis made the following motion:

"I move that Holmes review with Greene the financial condition of the District and if in his opinion deemed advisable that reasonable sums of money should be placed in the Pueblo Savings & Trust Company and in the Arkansas Valley Bank of Pueblo on Certificates of Deposit bearing 2% interest, the amount of the deposits to be covered by an escrow agreement whereby the receiving banks place in escrow an adequate collateral to guarantee the total amount of the deposit.

Seconded by Pryor, unanimously carried.

There being no further business, the meeting adjourned.
