

Further discussion was had regarding work on the River Levee opposite the Union Depot. It was agreed that the Directors and the District Engineer would go together to inspect the condition to better satisfy themselves as to what work was necessary.

Holmes reported on the comparative costs of a 4 inch wire reinforced poured slab as against the cost of a 2 inch wire reinforced gunite slab.

The present interest rates were discussed on the Certificates of Deposits that the District has in the different banks. All Certificates will be on the new rate of 3½ percent by May 20, 1962.
