Elliot's report on the repair work done by Weicker, by the State Highway Department and by the D&RGW RR Co., (said report being dated 31 March, 1959,) was read and approved and ordered filed.

Holmes stated that an Agreement between the Southern Colorado Power Company and the Pueblo Conservancy District permitted the Southern Colorado Power Company to put a power line from the vicinity of Runyan Field to the new structure of the Certified Concrete Company. Holmes read a copy of this agreement which was approved by Holmes and Mathis - the only two Directors present. Copy of this agreement is filed in the Southern Colorado Power Company file of the District.

At the Meeting of the Board of Directors held on April 25, 1958, a Resolution authorizing the Pueblo Conservancy District to intervene "IN THE MATTER OF SOUTHEASTERN COLORADO WATER CONSERVANCY DISTRICT" was adopted. Subsequently on April 2, 1959, an Order was issued by the District Court to the effect that the Pueblo Conservancy District be "dismissed as intervenor in the above entitled proceedings, or otherwise as a party in interest therein; and without costs". Copy of this Order is attached hereto.

Referring to the minutes of the meeting of February 20, 1959, Holmes read a copy of the lease Rose had prepared on the 3/4 acre of ground in question. Mathis moved the lease as drawn by Rose be approved and Holmes concurred.

A copy of an Amendment dated April 8, 1959, to the gravel removal permit dated September 13, 1952, was read by Holmes who moved its approval. Mathis concurred.

There being no further business, the meeting adjourned.
