MINUTES OF A SPECIAL MEETING OF THE BOARD OF DIRECTORS OF THE PUEBLO CONSERVANCY DISTRICT

June 13, 1938

A special meeting of the Board of Directors of The Pueblo Conservancy District was held in the office of the District at 10 A.M. June 13, 1938. Directors present: Holmes, Mathis and Pryor.

The meeting was presided over by John M. Holmes, president. City Commissioner Geo. J. Stumpf and City Engineer Si. Elliott were also present at the meeting.

Mr. Holmes said the purpose of the meeting was to hear a report from City Engineer Simon Elliott to the effect that the south abutment of the Union Avenue Viaduct was in danger of slipping due to sloughing off of the dirt originally surrounding that abutment. Considerable discussion was had relative to the matter and it was finally decided for Mr. Elliott to endeavor to get the services of Ross May - a former engineer on the Conservancy project-and go into the matter of the best way to protect the abutment from further slipping to protect the south end of the viaduct. Motion was made by Mr. Mathis that Mr. May and Mr. Elliott try to work out some plan for the protection of the abutment and that if a feasible plan could be found the expense of the work would be borne by the District. Seconded by Mr. Pryor, all voting in favor of the motion.
