A special meeting of the Board of Directors of the Pueblo Conservancy District was held at the office of the District, 113 West Fifth Street, on June 21, 1945 at 7:30 P.M.

Motion was made by Mr. Holmes and seconded by Mr. Mathis and carried to the effect that the 158 unsigned cancelled bonds with coupons attached now in the custody of the Treasurer be destroyed by fire by the Treasurer in the presence of one or more of the directors of the District. (These bonds were ordered cancelled by resolution of the Board of Directors of the District on December 15, 1925). Mr. Holmes also included in his motion the stipulation that after the bonds were burned, the witnesses to the burning certify that the bonds had been burned and that the numbers of the bonds burned be listed in the certificate of destruction.

There being no further business, the meeting adjourned.
