Elliot reported that the spring work with the exception of a few minor items, which can be taken care of this fall, have been completed.

A roundtable discussion was held with reference to the Valley Concrete Company of Rocky Ford, Colorado, taking over the concrete and sorting plants of the Certified Concrete Company. The Valley Concrete Company desire a different contract with the District for digging gravel, other than the one held by the Certified Concrete Company. It was moved by Mathia and seconded by Rhoades that Holmes should have Attorney Rose come to the City and work out a new contract over a longer period.

A party by the nameof Sil Gennetta, 2402 West Eleventh Street, west of Dry Creek desires to use Block 27, A.C. & W. 2nd Filing, for pasture. Holmes was instructed to give Gennetta such privilege, subject to revocation if his activities become a nuisance to the surrounding neighborhood.

Holmes submitted a new contract from the General Outdoor Advertising Company for lease of a piece of Conservancy land lying just north of the river levee adjacent to Santa Fe Avenue on the east of the new Freeway on the west - for a rental of \$126.50 per annum, payable in advance. It was moved by Rhoades and seconded by Mathis that the contract be signed.

Ambrose Spitzer submitted a request for placing a fence along the levee on the south side of Santa Fe Avenue, running between Santa Fe Avenue and the new Freeway fence on the west. It was moved by Mathis and seconded by Rhoades that permission be given for the construction of a fence - to be subject to supervision of construction by the District.

There being no further business, the meeting adjourned.
