MINUTES OF A SPECIAL MEETING OF THE BOARD OF DIRECTORS OF THE PUEBLO CONSERVANCY DISTRICT

July 24, 1944

A special meeting of the Board of Directors of The Pueblo Conservancy District was held at 7:00 P.M. July 24, 1944 in the office of the District.

Directors present: John M. Holmes, W. T. Mathis and Frank Pryor Jr. The meeting was called to order and presided over by John M. Holmes, president of the District.

Clarence Studzinski, City Engineer was present at the meeting which was called to discuss the break in the south bank of the levee just west of the South Santa Fe Avenue bridge caused by the sever rain storm of July 18th. There was a frank discussion as to whether the surface water rushing through the underpass to the mesa, had caused the sewer line to break and in turn washing out the levee dirt back of the concrete, or whether the concrete had given way first and caused the sewer to burst tearing out more levee. Ways and means of repairing the break were discussed and Mr. Studzinsky was asked to procure figures showing the amount of surface water that came through the underpass from the mesa to determine what size pipes should be installed to carry any future water from storms. He said he would get these figures and at a later meeting more definite information and planning could be had.

Mr. Studzinski then left the meeting and routine business was taken up. Minutes of meetings of March 30 and April 13, 1943 were read and approved as written.
