Letter was submitted from the City of Pueblo with reference to renewal of sidewalk on South Union Avenue between the River Bridge and 308 S. Union. Bids were submitted. It was moved by Rhoades, seconded by Mathis and carried that the sidewalk be renewed and the contract given to W. N. Mayber and Sons, at a price of $40 \not e$ per square foot.

Report was made by Holmes on further negotiations of oil lease for drilling on Section 36 at Rock Canyon Barrier. Due to restrictions that would of necessity have to be placed, the interested parties declined to enter into lease agreement with the District, so subject was dropped.

Holmes then submitted plan of Dog Pound House which had been handed to him by City Manager Fellows, with a request that they be permitted to place such building in the old river channel east of So. Main Street adjoining the property as owned by an oil company facing on So. Main Street. Rhoades entered objection to same, which was sustained by Mathis. Holmes was instructed to offer three other locations, same to be submitted to City Manager Fellows and reported on at a later meeting.

There being no further business coming before the Board, the meeting was adjourned at 11:00 A.M.
