With reference to funds of the District deposited in the Arkansas Valley Bank, Greene reported that on September 16, 1953, a six months time deposit certificate for \$25,000 matured. In compliance with Greene's request for approval of the Board, Mr. Pryor moved that the increasing of the amount in the checking account at the Arkansas Valley Bank to \$50,000 be ratified and approved. Mr. Mathis seconded the motion which was unanimously carried.
