# PART III. PROPERTY AFFECTED BY THE PLAN

#### INTRODUCTION

The property that will be affected by the execution of the Plan of The Pueblo Conservancy District is all situate in Pueblo County and The City of Pueblo, State of Colorado, and is of two general classes: first, the property to be damaged or taken; and second, the property that will be benefited. Practically all of this property is within the limits of the District, but a small portion is outside of those limits and is classified separately.

Accordingly, all the property affected by the Plan is described under the main headings as follows:

#### Description

The Pueblo Conservancy District, as defined in the order of the Court of May 14, 1922, includes the following lands within Pueblo County, State of Colorado, to-wit:

T. & S. F. Ry.; thence southeasterly along said southerly right-of-way line of A. T. & S. F. Ry., to E line of Sec. 6, T 21 S, R 64 W, 6th P. M.; thence southerly along E line of said section to southerly line of county road known as the Santa Fe Trail; thence northwesterly along southerly line of said Santa Fe Trail, County Road to the Eighth Guide Meridian; thence W to the southwesterly right-of-way line of D. & R. #### 2. Pueblo County
