

MINUTES OF A SPECIAL MEETING OF THE BOARD OF DIRECTORS OF  
THE PUEBLO CONSERVANCY DISTRICT

January 15, 1924.

Pursuant to due call and notice a special meeting of the Board of Directors of the Pueblo Conservancy District was held in the Council Chambers of the City Hall, Pueblo, Colorado, at 2 o'clock P.M. January 15, 1924.

The meeting was called to order and presided over by Chas. W. Lee, president of the district. Minutes were kept by the Secretary, E. D. Spruill. Directors present: Lee, Nuckolls, Raber. Directors absent: none. Treasurer Raymond C. Thatcher, General Counsel Chas. M. Rose and Mr. Arthur E. Morgan of the Dayton Morgan Engineering Company, chief engineer were also present.
