Mathis moved and Rhoades seconded the motion that Holmes proceed with repairs needed as authorized in Elliot's report of October 1959. Motion was carried.

Holmes reported that it had come to his attention that Edward Boyle of the Certified Concrete Company had removed a great deal of sand and gravel on the north side of the river east of the Santa Fe Avenue bridge and that he had left a large hole and which should be filled with overburden. Holmes said he saw Boyle about this and Boyle had promised to fill the hole. Not having complied with this promise as soon as Holmes thought he should, Holmes saw him again and Boyle agreed to fill the hole. Holmes says he will see him again and demand action.

Mention was also made of the fact that Urban Renewal Authority desire to use certain parts of the old river channel between Victoria Avenue and Main Street for parking space, providing they can acquire other properties to complete their project. The District signified their willingness to cooperate if and when the occasion arises.
