

MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS  
OF THE PUEBLO CONSERVANCY DISTRICT

April 8, 1924.

The regular weekly meeting of the Board of Directors of the Pueblo Conservancy District was held in the office of the District, Room 740 Thetcher Block at 10 A. M. April 8, 1924. The meeting was called to order and presided over by Chas. W. Lee, president of the District. Directors present: Lee; Reber; Nuckolls. Directors absent: none. The minutes of the meeting of April 1, 1924, were read, and upon motion, approved.
