Holmes called attention to plans and agreement entered into between the Pueblo Conservancy District and the Colorado State Highway Department with reference to the new Fourth Street bridge and Freeway. Said plans, specifications and agreement had been reviewed by Roae, Elliot and Holmes and the welfare and requirements of the District are adequately taken care of. Plans and Specifications are on file.

Holmes also brought to the attention of the Directors the present condition of the slag facing levee east of Santa Fe Avenue on the north side of the river, with the possible thought in mind of placing a toe wall at the bottom of the slag facing and grouting the slag facing with concrete. No definite action was taken pending further examination and study of the situation.

Mathis moved and Pryor seconded the motion which was unanimously carried authorizing Holmes to execute a revokable Grant of Easement to the MST&T Co., pertaining to a 10 foot strip of ground from the South end of the Santa Fe Avenue bridge West for 500 feet more or less - form of easement to be approved by Charles M. Rose.

There being no further business, the meeting adjourned.
