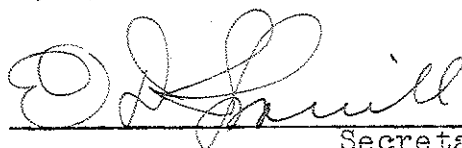
officer as part of proceeds of bonds of said District.

Ayes: Raber; Nuckolls; Lee.

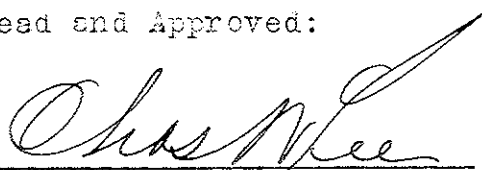
Thereupon the Chairman declared the resolution duly adopted.
