August 31, 1954

A Special Meeting of the Board of Directors of The Pueblo Conservancy District was held at the office of the District, 113 West Fifth Street, at 10:00 o'clock A. M., on August 31, 1954.

The minutes of the meeting of June 25, 1954, were read and approved.

Mr. Holmes submitted a notice which he and Mr. Greene propose to send to property owners who are delinquent in their tax payments. The notice was approved by both Mr. Mathis and Mr. Pryor.

Greene called attention to the fact that the District own \$300,000.00 U. S. Saving Notes - Series "B", which will mature next May 15, 1955. The Government has discontinued issuing these notes nor could all of the \$300,000.00 be reinvested in Series "K" notes because the Government will only issue to one investor \$200,000.00 in "K" notes in any calendar year. The Conservancy District purchased \$100,000.00 "K" notes on April 1, 1954, and Greene stated it appeared advisable to him for the District to cash \$100,000.00 of the Series "B" notes and reinvest this amount in Series "K" notes before December 31, 1954. Mr. Pryor moved and Mr. Mathis seconded the motion, which was carried, that Holmes and Greene do as they see fit regarding changing funds from one type of Government security to another type.

There being no further business, the meeting adjourned.
