

MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS
OF THE PUEBLO CONSERVANCY DISTRICT

August 4, 1925

The following work orders were read:

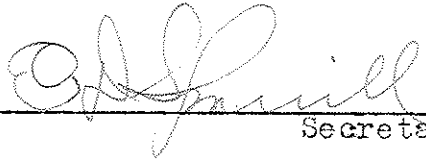

Colorado Power Co. intake.

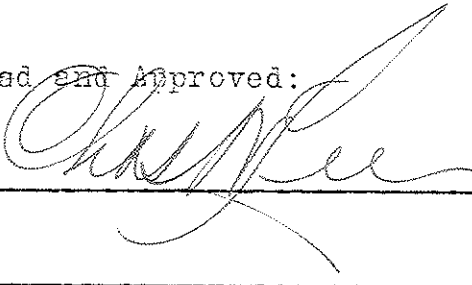
Mr. Breckenridge made a motion that these orders
