176 Aug. 28 Platt Rogers, Inc. Proceed with construction of gravity section of dam.

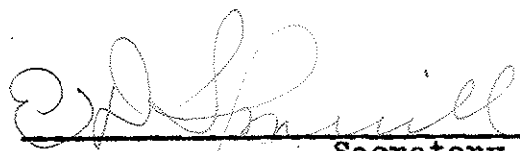
Mr. Nuckolls moved that these orders be approved as read. Mr. Breckenridge seconded the motion, the vote being as follows:

Ayes: Nuckolls; Breckenridge; Lee.

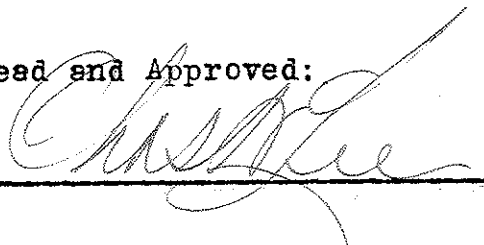
Nays: none.
